We begin with a delightful afternoon visit to **Old Westbury Gardens**, listed on the National Register of Historic Places, and the former home of the Phipps Family. With its breathtaking views, the Montauk Point Lighthouse is the oldest lighthouse in New York State and majestically stands at Long Island's easternmost point. To make our day complete, we'll enjoy another delicious dinner together. (Breakfast, Dinner)

### **Thursday, September 29:**

Enjoy breakfast this morning, before we depart our hotel and tour along Long Island's **Gold Coast**, a virtual Who's Who of High Society.
